FOOTNOTES:

1. Atrium - Income - 1997 only, several benefactors contributed specifically to the opening of the Atrium at San Martin's.

2. Atrium - Expense - Travel & Training \$591.25, Materials for classroom \$156.45, Books & Membership Fees \$254.08, and misc. \$136.03. Madre de Dios reimbursed us 3/2/98.

3. Building and Maintenance - Includes renovation of San Martin's for use as an Atrium. \$2,276.36.

4. Charity - includes \$997.15 representing the net loss taken on the purchase/renovation/sale of 401 Adams St. house to Estrada family.

5. Household - includes \$400.00 for tree trimming,

6. House Insurance - this represents 1997 and 1998 premiums. In November 1997 our carrier United Southern bankrupted. We then began coverage with Catholic Mutual of Omaha. The rate change of \$516 to \$748 now includes a general liability coverage.

7. Staff - This includes three Phoenix/Toronto air fares and one for Teresa Davis, Phoenix/Raleigh.

8. Youth - Madonna House served as the clearing account for the joint parish efforts in Youth Ministry. We are reimbursed by the parishes: Madre de Dios 40% and St. Joseph 60%.

9. Net Income - \$10,000 represents a donation recieved in 1997 towards the puchase of a new vehicle. Plymouth Van purchased 1/16/98.
