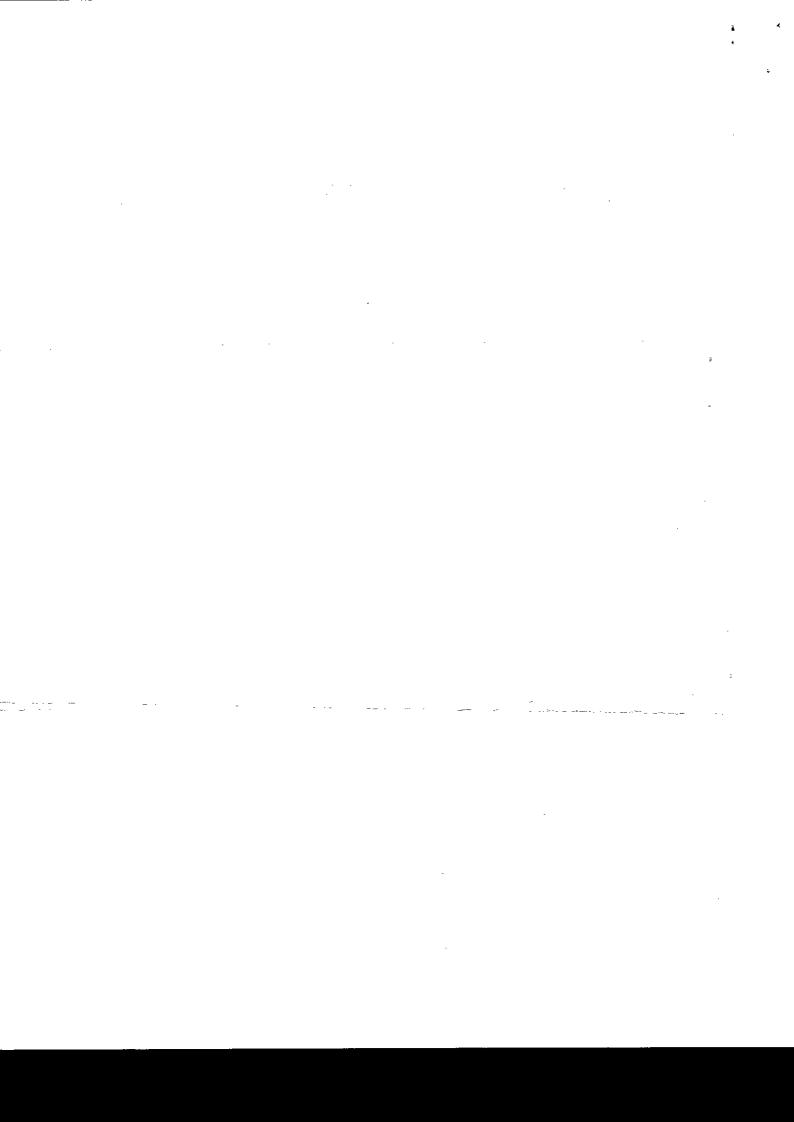

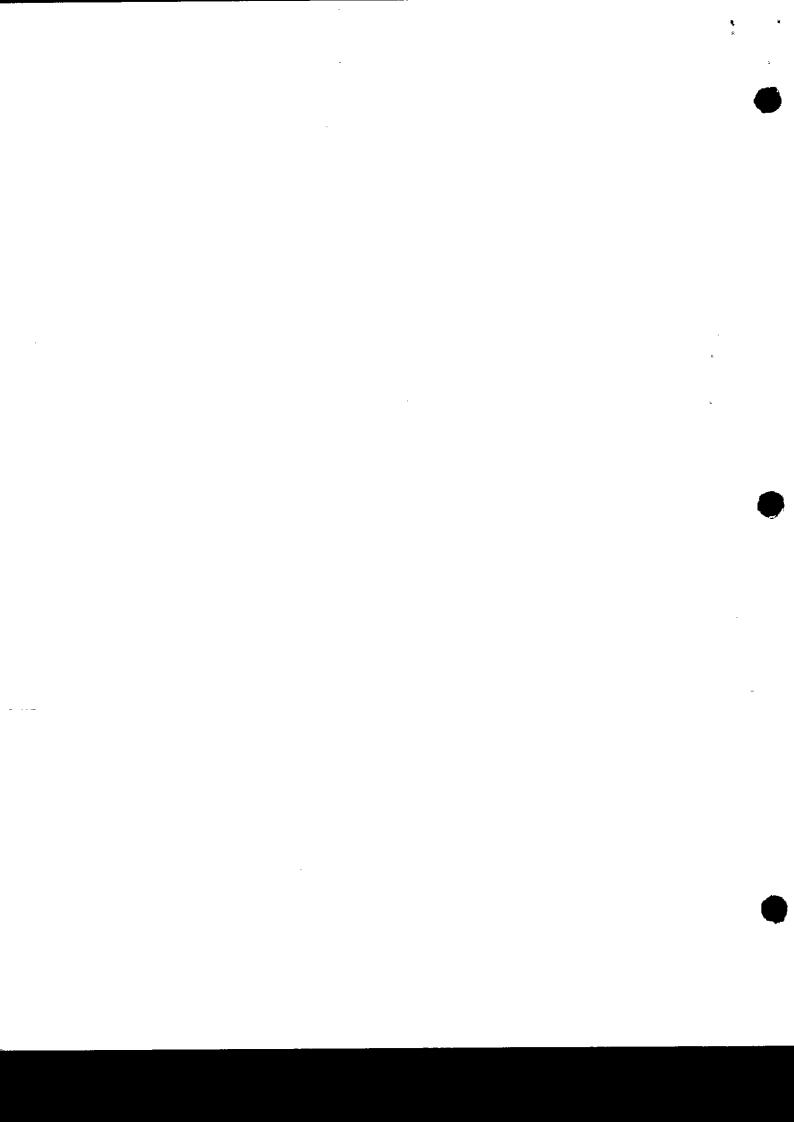

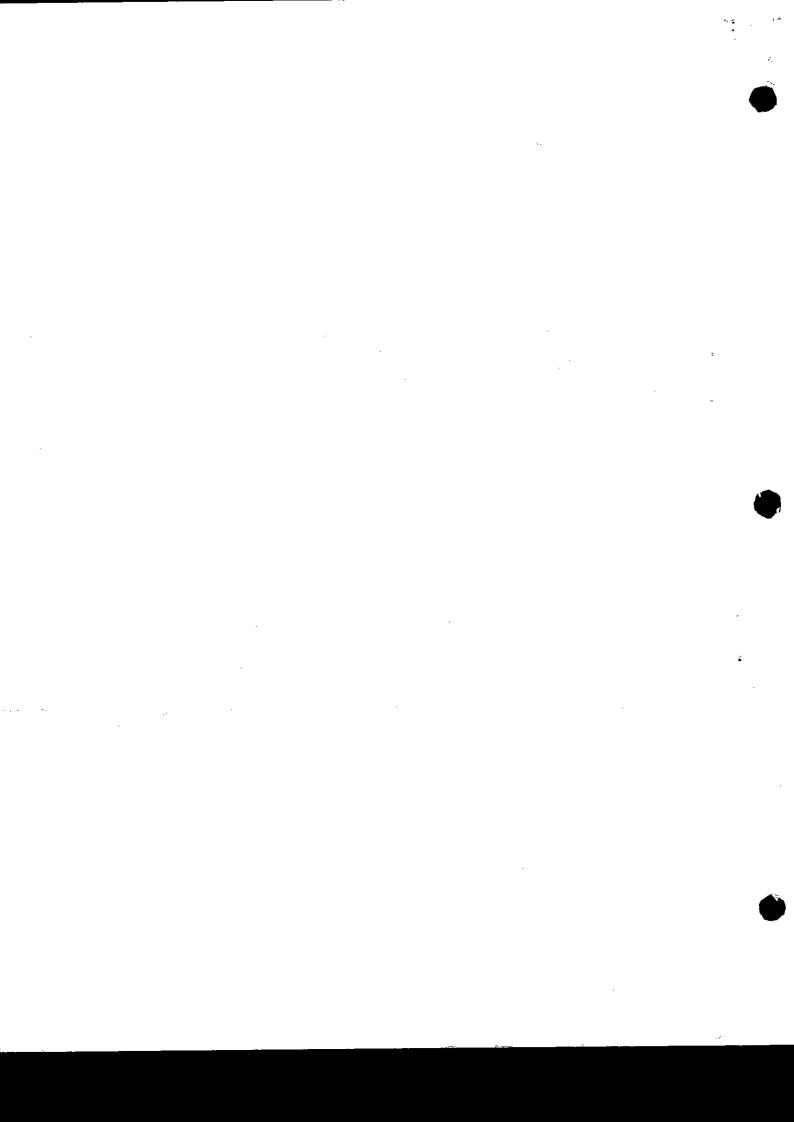

Dear Jason:

I have enclosed for your attention a Corporation Annual Report & Certificate of Disclosure that we just received from the Arizona Corporation Commission (the "ACC") with respect to Vista Fairways at Westbrook Village Association (the "Association"). This Report covers the fiscal year 98-99 and must be filed with the ACC no later than April 27, 1999. The preprinted information at items 7 (Officers) and 8 (Directors) should be reviewed for accuracy with any necessary additions or changes made directly on the Report. If there are no changes to the information, you should place a checkmark where indicated. With regard to the Directors, please note that pursuant to the new nonprofit corporation code that took effect on January 1, 1999, you are no longer required to have a minimum of three Directors on the Board; you must have at least one Director. Items 9A (Members), 10 (Certificate of Disclosure) and 11 (Statement of Bankruptcy) must be completed, and the Report must be signed by a duly authorized officer in item 12 at the bottom of page 3 of the Report (in previous years the signatures of two corporate officers were required; this requirement also changed with the new nonprofit corporation code). A financial statement must be attached to the Report or it will not be accepted for filing. The filing fee will be \$10.

As you and I have previously discussed, the address of the Association's known place of business should be changed from L and R Service Co. (which is an affiliate of this firm) to an address that the Association designates. You have informed me that this was taken care of with the ACC; however, as you will note, the Annual Report still shows L and R Service Co.'s address as the known place of business. Accordingly, I have struck through our address, and you must now insert the address that the Association wishes to use. When the Annual Report is filed, the ACC will finally then officially change the Association's address.

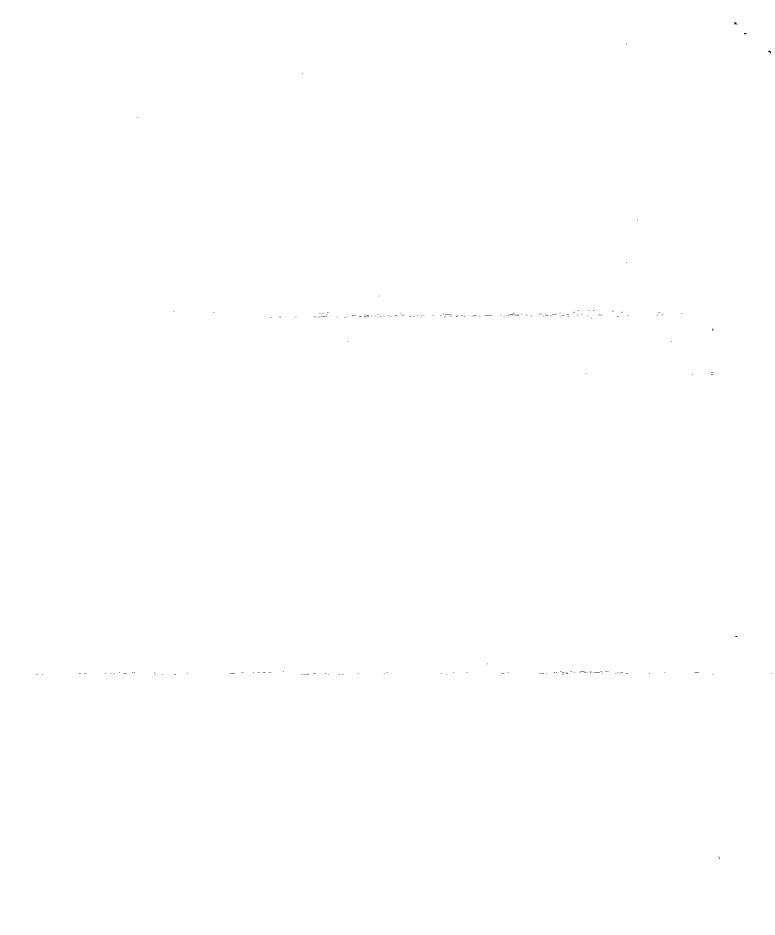
