Business

The annual Neighborhood Beautification Day was established as Saturday May 9th. We will begin cleanup of the area along Overton Road at 6:00 a.m. All households are encouraged to contribute to this project. If time and peoplepower allows, we will also perform cleanup in the common area access road to the detention pond and along Camino del Fierro. Bagels and juice will be served compliments of the association.

Breaking tradition, we selected a different weekend for the Block Party. The Block Party will be held on Sunday May 17th. The PotLuck will begin at 5:00 p.m. The association will provide the meat, buns, condiments, and soda. Kewanee St. Residents are asked to bring side dishes and Kanawha St. Residents are asked to bring desserts. This year we also voted to spend as much as \$100 for a jumping castle at the party. Jeannie

Weissenborn volunteered to do the shopping for the Block Party, Randy and Lee Ann Hamilton will arrange for the jumping castle and Kevin and Debbie Robinson volunteered to prepare the condiments.

A lengthy discussion was held on a proposal to organize the neighborhood to utilize one garbage collection company. The intent of the proposal was to obtain a better rate and to reduce the garbage collection traffic in the neighborhood. Quotes were solicited from several companies. TNT was the only company that had provided a written quote at the time of the meeting. Waste Management was contacted after the meeting. It appears that with a minimum of 80% participation from the community, a rate of approximately \$9.00 per month per household could be contracted. Rates are dependent on billing through the association or left to the individual household. The details of the proposals will be formulated and put forth to the association membership for a vote in the near future.

The National Night Out date is August 4th (the Neighborhood Watch Coordinator, Lee Ann Hamilton will coordinate with others to plan an ice cream social).

A brief discussion was held on the health and safety hazards of the property to the north of our neighborhood. It was agreed that if someone wished to draft a letter to some authorities on the situation, the officers of the Association would be willing to review and sign the letter.
