- 1. <u>Name</u>: The name of the Limited Liability Company is: TIMELESS APOTHECARY OF SEDONA, L.L.C.
- 2. <u>Known Place of Business</u>: The address of the known place of business of the Company is: 80 Quail Circle, Sedona, Arizona, 86351; located in Yavapai County.
