

Ladies and Gentlemen:

Enclosed are the original and one copy of the Articles of Organization and Consent of Statutory Agent for the above-referenced entity previously presented to you on June 16, 2005, and incorrectly rejected on July 6, 2005. Please let me explain.

The first Articles of Organization, under the name **Bedrock of Arizona, LLC**, were filed on May 6, 2005 (complete with the Statutory Agent Acceptance letter and the expedited filing fee check in the amount of \$85.00 which was presented by you and paid on May 13, 2005). Such articles were rejected and returned by your letter of June 8, 2005 (copy enclosed).

I subsequently re-named and re-filed the second Articles of Organization (and Statutory Agent letter) with you on June 16, 2005, under the **new** name of **Bedrock Partners of Arizona, LLC**. However, this filing was mistakenly rejected and returned by your letter dated July 6, 2005 (copy enclosed) and received in my office on July 12, 2005.

Clearly, the July 6, 2005 rejection of the second, re-named Articles of Organization was incorrect in that the July 6th rejection was based upon the old, first set of Articles filed under the name Bedrock of Arizona, LLC, and **NOT** upon the second set of Articles filed under the new name Bedrock Partners of Arizona, LLC.

On July 12, 2005, I telephoned your office and was told that I could not discuss this with an examiner, and that my only recourse was to leave a voice mail for an examiner who would return my call within seven days. I left a voice mail message as directed.

However, I did not receive a response to my voice mail, so I called again on July 22, 2005. The clerk relaying the information to me even took the initiative and contacted her supervisor to see if

there was any way we could shorten the response time for communicating my problem to an examiner, etc. But I was again told that my only recourse was to leave a voice mail for an examiner again. So I did.

However, I still have received no response from an examiner to my voice mail messages.

Therefore, I have attached and am resubmitting the June 16, 2005 filing of the original Articles of Organization and Statutory Agent Acceptance letter for **Bedrock Partners of Arizona, LLC**. Please file the original and hold the copy for pick up by my attorney service, Hawkins and E-Z Messenger Legal Support Providers, LLC.

Please push this through the system as quickly as you can. My client has patiently waited now for nearly three months – the first month of delay was understandable. The last two months are beginning to take their toll on my client.
