Article X INDEMNIFICATION OF OFFICERS

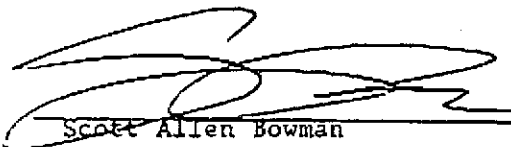
