Statement Attached to and Made a Part of The Annual Report for DMB Associates, Inc. File No. 0172559-6 Details relating to Question 11B—Bankruptcy and Receivership Matters

#### Introduction

FROM-DMB Associates

Bennett Dorrance is a director of DMB Associates, Inc. Mr. Dorrance and his affiliates make private investments in numerous businesses. Often Mr. Dorrance will acquire a significant position (greater than 20%) in an organization. In addition, Mr. Dorrance will generally take a seat on the board of directors or other governing body to monitor the investment, but they do not assume managerial control. The address of Mr. Dorrance is 7600 East Doubletree Ranch Road, Suite 300, Scottsdale, Arizona 85258. Two of Mr. Dorrance's investments may be reportable under Section 11B of the Certificate of Disclosure.

### Belae Brands

Belae Brands, Inc., 15458-A North 28th Avenue, Phoenix, Arizona 85053, filed for bankruptcy on January 17, 2003 in the United States Bankruptcy Court for the District of Arizona, Case No. B-03-00836-PHX-GBN. At the time of Belae's filing, a trust controlled by Mr. Dorrance was a major holder of preferred stock. Belae Brands was incorporated on September 17, 1998 in the State of Delaware, and transacted business in all 50 states. Belae Brands, Inc. converted its bankruptcy filing to Chapter 7 on May 27, 2004 and is no longer in operation.

#### XPO Network Limited

XPO Network Limited, c/o Smith & Williamson, No. 1 Bishops Wharf, Walnut Tree Close, Guildford Survey GU14RA UK, Attention Robert Horton, sought a court-appointed liquidator for its business on September 6, 2002 in the United Kingdom. At the time of XPO's filing, Mr. Dorrance was on the board of directors and was a major holder of preferred stock. XPO was incorporated on January 31, 2000 in the United Kingdom and transacted business worldwide. The name and address of the liquidator is as stated above.
