ARTICLES OF INCORPORATION OF A TAX-EXEMPT ARIZONA NON-PROFIT CORPORATION

- 1. The name of the corporation is Northern Arizona Martial Arts School of Chung Do Kwan, Incorporated.
- 2. The purpose for which the corporation is organized is education, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding section of any future federal tax code), through the teaching of traditional Chung Do Kwan Tae Kwon Do.
- 3. The character of affairs of the corporation will be fostering the physical growth, psychological growth, spirit, self discipline, respect for others and self, physical and mental focus, and self confidence of its youth and adult students in the community through the teaching of traditional Chung Do Kwan Tae Kwon Do. The corporation will present formal instruction as its primary function. In doing so, the corporation will have: a regularly scheduled curriculum; a regular faculty of qualified instructors; a regularly enrolled student body; and a place where its educational activities are regularly carried on.
- 4. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in paragraph 2. No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986, (or the corresponding provision of any future United States Internal Revenue Laws) or; (b) by a corporation, contributions to which are deductible under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Laws).
- 5. Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all its assets exclusively for the purposes of the corporation in such a manner, or to such other organizations organized and operated exclusively for charitable, educational, religious or scientific purpose as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Laws) as the Board of Directors shall determine. Any such assets not disposed of shall be disposed of by the

Superior Court of the county in which the principle office of the corporation is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.
