

Articles of Incorporation of Northern Arizona church of Christ, Inc.

- 1. NAME: The name of the Corporation is Northern Arizona church of Christ, Inc. (a non-profit corporation.)
- 2. PURPOSE: The purpose for which this Corporation is organized is religious. This Corporation is formed exclusively to engage in the activities of a church. within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- 3. CHARACTER OF AFFAIRS: The character of affairs for the Corporation will be: (a) public assembly for praise and worship of Jesus Christ; (b) evangelism of the Gospel of Christ; (c) Bible study; (d) biblically-based activities that promote the love of Jesus Christ.
- 4. No part of the net earning of the Corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements,) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code, as amended, (or the corresponding provision of any future United States Internal Revenue Law) or: (b) by a corporation, contributions to which are deductible under Section 501(c)(3) of the Internal Revenue Code, as amended, (or the corresponding provisions of any future United States Internal Revenue Laws.)
- 5. Upon dissolution of the Corporation, the board of directors shall, after paying or making provision for the payment of all liabilities of the Corporation, dispose of all its assets exclusively for the purposes of the Corporation in such a manner, or to such organizations organized and operated exclusively for charitable. educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code, as amended, (or the corresponding provision of any future Internal Revenue Law) as the board of directors shall determine. Any such assets not disposed of shall be disposed of by the Superior Court of the county in which the principle office of the Corporation is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.

- 6. The power or indemnification under the Arizona Revised Statues shall not be denied or limited by the bylaws.
- 7. BOARD OF DIRECTORS: The initial board of directors shall consist of 5 directors. The names and addresses of the persons who are to serve as the directors until the first annual meeting of the members or until their successors are elected and qualified are: 1....
