ARTICLES OF INCORPORATION OF: G S W C REALTY & BUILDING CORP Article I The name of this corporation is G S W C Realty & Building Corp. Article II The purpose for which this Corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Arizona, as they may be amended from time to time, either solely or as a joint venture with any other person, partnership or corpora-tion. Article III The Corporation initially intends to conduct the business of General Residential Contractor, Article IV The Corporation shall have the authority to issue 10,000 shares of common stock with a par value of \$0.00. Article V The Shareholders, from time to time, of the stock of the Corporation shall have preemptive rights as to the stock then, or employees of the Corporation or of any affiliate thereof, and no shareholder approval or ratification of any issuance of rights and options shall be required.
