**ARTICLES OF INCORPORATION OF:  
G S W C REALTY & BUILDING CORP.**

Article I The name of this corporation is G S W C Realty & Building Corp. Article II The purpose for which this Corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Arizona, as they may be amended from time to time, either solely or as a joint venture with any other person, partnership or corporation. Article III The Corporation initially intends to conduct the business of General Residential Contractor. Article IV The Corporation shall have the authority to issue 10,000 shares of common stock with a par value of \$0.00. Article V The Shareholders, from time to time, of the stock of the Corporation shall have preemptive rights as to the stock then, or employees of the Corporation or of any affiliate thereof, and no shareholder approval or ratification of any issuance of rights and options shall be required. Article VI The Corporation may issue rights and options to purchase shares of stock of the Corporation to directors, officers or employees of the Corporation or of any affiliate thereof, and no shareholders approval or ratification of any issuance of rights and options shall be required. Article VII The name and address of the Statutory Agent in Arizona is: American Contractor Business Services, Inc. - Bruce A. Evers - president, 2041 W. Glendale Ave. Phoenix, AZ 85021. Article VIII The street address of the known place of business of the Corporation is: 7555 N. Oracle Rd., Tucson, Arizona 85704. Article IX The initial board of directors shall consist of 1 (One) or more directors. The name and address of the person(s) who serve as the director(s) until the first annual meeting of shareholders or until his successor is elected and qualified is Mark Carey Wierzbinski, 7555 N. Oracle Rd., Tucson, Arizona 85704. The number of directors thereafter shall be fixed by the Bylaws. Article X The following persons shall serve as officers of the Corporation to hold the following offices until the first meeting of the Shareholders or Board of Directors, until their earlier resignation or removal or until their successors are chosen and shall qualify Mark Carey Wierzbinski, 7555 N. Oracle Rd., Tucson, Arizona 85704, President. Article XI The name and address of the incorporator is: Mark Carey Wierzbinski, 7555 N. Oracle Rd., Tucson, Arizona 85704. All powers, duties and responsibilities of the Incorporator shall cease at the time of delivery of these Articles of Incorporation to the Arizona Corporation Commission for filing. Articles of Incorporation of G S W C Realty & Building Corp. Article XII The Corporation shall indemnify any person that incurs expenses or liabilities by reason of the fact he or she is or was an officer, director, employee or agent of the Corporation. This indemnification shall be mandatory in all circumstances in which indemnification is permitted by law. Article XIII To the fullest extent permitted by the Arizona Revised Statutes as the same exists or may hereafter be amended, a director of the Corporation shall not be liable to the Corporation or its shareholders for monetary damages for any action taken or any failure to take any action as a director. No repeal, amendment or modification of this Article, whether direct or indirect, shall eliminate or reduce its effect with respect to any act or omission of a director of the Corporation occurring prior to such repeal, amendment or Modification. Article XIV The board of Directors of the Corporation may from time to time, cause the Corporation to purchase its own shares to the extent of the unreserved and unrestricted earned capital surplus of the Corporation.
