## IMPORTANT NOTICE REGARDING THE MAILING OF YOUR ANNUAL REPORT FORMS

Dear Valued Customer,

In an effort to decrease document-processing times and save taxpayer dollars, the Arizona Corporation Commission (ACC) will no longer be mailing annual report forms to corporations each year.

Beginning December 2008, the ACC will eliminate mailing paper annual reports and will instead institute a reminder system to file your annual report electronically. You will receive a reminder notice two months prior to your annual report due date. The reminder notice will outline the various options available to file your annual report form.

As many of you know, the ACC has electronic filing options that are now available to most corporation types. In addition to most profit, business and professional corporations, the ACC has recently added non-profit, corporate soles, and cooperatives to the electronic filing system.

Since filing on-line will be the fastest way to achieve good standing, you will no longer need to visit the ACC in person and wait in line to submit your annual report form.

Even though the ACC will end its practice of mailing annual report forms, the ACC will provide other options for you to obtain annual report forms.

- You can download an annual report form from our website at www.azcc.gov and mail it in.
- You can call the Annual Reports Section at 602-542-3285 to request an annual report form by mail or fax.
