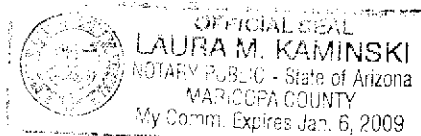

Pursuant to A.R.S. §10-1105(A), the undersigned corporations, by and through the undersigned officers, hereby set forth the following Articles of Merger:

1. Parties. The names of the corporations that are parties to the merger are: CTM Magnetics, Inc. (Surviving Corporation); MacLennan Enterprises, Inc. (Disappearing Corporation).
 2. Plan of Merger. The plan of merger is set forth in that certain agreement between the parties dated October 30, 2007 and titled Agreement and Plan of Merger, a copy of which document has been delivered to the Arizona Corporation Commission and which provides for an effective time and date for the merger as of 5:00 P.M. M.S.T. on November 30, 2007.
