

## A LIMITED LIABILITY COMPANY

- 8. Name. The name of the limited liability company is DD6 ARIZONA, LLC.
- 9. Registered Office. The address of the registered office of the limited liability company is 3160 E. Main #81, Mesa, Arizona 85213.
- 10. <u>Agent for Service of Process</u>. DURFEE & PHELPS, PLLC, 1423 S. Higley Road, Ste. 127, Mesa, Arizona 85206, is appointed, and by signature below accepts appointment, to act as the agent for service of process.
- 11. <u>Members at Time of Formation</u>. There are or will be two or more members at the time the limited liability company is formed. There are or will be non-voting and voting ownership interests in the company.
- 12. <u>Date of Dissolution, Continuation of Business</u>. The limited liability company will exist in perpetuity, unless sooner dissolved by law or action of the members.
