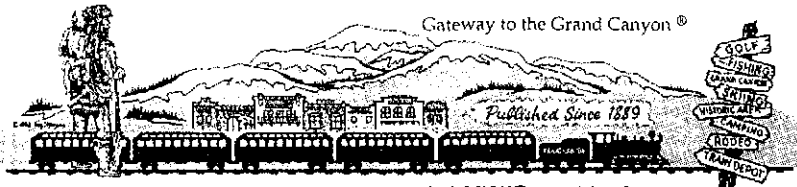

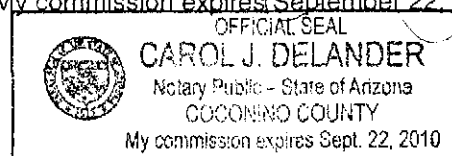

**ARTICLES OF INCORPORATION OF
DRABIK'S RETAIL SERVICES, INC.**

KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, have associated myself for the purpose of forming a corporation for profit under and pursuant to the laws of the State of Arizona, and for that purpose do hereby adopt the following Articles of incorporation.

ARTICLE I. Name. The name of this Corporation shall be DRABIK'S RETAIL SERVICES, INC. and its principal place of business shall be 12 E. Route 66, Flagstaff, Arizona 86001.

ARTICLE II. Purpose. The purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Arizona, as they may be amended from time to time. ARTICLE III. Initial Business. The corporation initially intends to engage in the general business of retail clothing and related services.

This statement of initial business is not to limit the character of the business which the corporation ultimately conducts.

ARTICLE IV. Capitalization. The aggregate number of shares which the Corporation shall have authority to issue shall be ONE MILLION (1,000,000) SHARES, being of one class, to-wit: common stock. There shall be ONE MILLION (1,000,000) SHARES of common stock with a par value of ONE DOLLAR (\$1.00) per share.
