AMENDMENT AND RESTATEMENT
OF ARTICLES OF
INCORPORATION

CORPORATION: HENRY-DAVIS, INC.

MEETING: Shareholders and Directors Meeting held on January 2, 2007

The undersigned, being all the Directors and Shareholders of this corporation, hereby certify that the following is a true and correct copy of a resolution adopted by consent for this corporation as of the Effective Date under the statutes of the State of Arizona and under this corporation's By-Laws allowing directors and shareholders to take action by consent. At that meeting were present, in person or by proxy, the 600 shares, which constitute 100% of the outstanding voting stock of the corporation. With 100% of the outstanding shares being present voted to approve this amendment. There were no votes against this amendment. The number of votes cast for approval of this amendment was sufficient for approval. A resolution was duly, regularly, and unanimously adopted by the shareholders of the corporation to amend and restate the Articles of Incorporation in their entirety to read as follows:

1. Name. The name of the corporation is HENRY-DAVIS INC.

2. Principal Place of Business. The address of the corporation is 819 W. Prime Street, P.O. Box 768, Gila Bend, Arizona 85337.

3. Statutory Agent. DURFEE & PHELPS PLLC, 1423 S. Higley Road, Ste. 127, Mesa, AZ 85206, is appointed and consents to act as the statutory agent.

4. Capital Stock. The corporation is authorized to issue 100,000 shares of Voting stock, and 900,000 shares of Non-Voting stock. The Voting and Non-Voting shares are identical except as to Voting rights. The shareholders shall have preemptive rights on the issuance by the corporation of shares or securities convertible into shares and preferential rights on the sale of shares by shareholders.

5. Director and Officer Liability. To the maximum extent permitted by law, a director or officer of this Corporation shall not be personally liable to the Corporation or its shareholders for monetary damages for any act or failure to act. Any repeal, amendment, or modification of this article shall not increase the liability of a director or officer of the corporation arising out of acts or omissions occurring before the repeal, amendment, or modification becomes effective.
