The execution, attestation, verification or acknowledgment of the document was defective because Boxes 10 and 11 on the Certificate of Disclosure should have been marked "Yes" because: (1) Box 10 was inadvertently marked "No" based upon a belief at the time that it was a correct answer. The Association's Board of Directors are volunteers and not attorneys. Except for Director Bill Fautsch, upon information and belief, none of the Board Members knew about the specifics of any issues, such as entry of a consent judgment, involving possible consumer fraud law violations involving a company in which Mr. Fautsch was involved. Mr. Fautsch did not believe it applied because, per the consent judgment, the consent judgment does not constitute an admission by the Defendants in the matter for any purpose of a violation of any state law, rule, or regulation nor does it constitute evidence of any liability. Furthermore, the consent judgment was made without trial or adjudication of any issues of fact of law, or finding of liability of any kind; and (2) Box 11 was inadvertently marked "No" based upon a belief at the time that it was a correct answer. None of the Directors, except for Mr. Fautsch, knew about a company in which Mr. Fautsch was involved that filed for Bankruptcy, but Mr. Fautsch neither reviewed nor signed the Certificate of Disclosure for this year. After the issues involving the foregoing were brought to their attention, and after consultation with legal counsel, the Association now interprets the above information as the type of information required to be disclosed in the Certificate of Disclosure.
