stock corporation under Article 10, Chapter 25 of the Arizona Revised Statutes ARTICLE I

The name of this Corporation is ENGLISH COOLIDGE CONGREGA-TION OF JEHOVAH'S WITNESSES, INC., Coolidge, Arizona. The street address of the known place of business for the Corporation is 300 W. Palo Verde, Coolidge, AZ 85128, ARTICLE II

The duration of the Corporation shall be perpetual ARTICLE III

The character of affairs that the Corporation intends to conduct is religlous and specifically (1) to provide

and maintain a proper place of worship for the benefit of Jehovah's Witnesses in and around the State of Arizona and those who desire to attend such worconducted by Jehovah's ship Witnesses in order to learn the truths of the faith and beliefs of Jehovah's Witnesses, which are based upon the Bible, the written word of Almighty God, Jehovah; and (2) to acquire by gift, legacy, bequest, purchase, or lease; hold and manage; and/or mortgage, sell, convey, or otherwise dispose of real estate and personal property in any lawful manner that may seem proper and best to provide and maintain such place of worship.
