**ARTICLES OF ORGANIZATION
OF
WB HOLDINGS, LLC**

KNOW ALL MEN BY THESE PRESENT:

The undersigned has this day set his hand hereto for the purpose of forming a limited liability company ("Company") under and pursuant to the laws of the State of Arizona, and for that purpose does hereby adopt these Articles of Organization.

ARTICLE I

The name of the Limited Liability Company is WB Holdings, LLC.

ARTICLE II

ARTICLE VII

To the fullest extent permitted by applicable law, the Company shall indemnify any person who is a Member or Agent of the Company against liability for monetary damages for acts or alleged acts and failure to act or alleged failures to act of such person with respect to the Company.
