3. <u>Character of Affairs</u>: The character of affairs of the corporation will be: 70 PERFORM PLAYS FOR ENDOYMENT AND IN BENEFITTING THE CENTENNIAL PARK COMMUNITY.

4. No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2.
