A Nonprofit Corporation

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporators hereby adopt the following Articles of Incorporation:

# **Article 1: Entity Name**

The name of this corporation is Terrain Publishing.

## Article 2: Membership

This corporation WILL have members. The membership provisions of this corporation shall be stated in the bylaws of this corporation.

# Article 4: Character of Affairs / Statement of Purpose

The purposes for which this corporation is organized are:

The purpose of this Corporation is to engage in any lawful act or activity for which corporations may be organized under the Nonprofit Corporation Law of Arizona, as they may be amended from time to time, provided, however, that the corporation shall only engage in acts or activities that are consistent with and in furtherance of its 501(c)3 tax-exempt purposes, which are described herein.

Said Corporation is organized exclusively for scientific, literary and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, including for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code. To the extent that the following conforms to such scientific, literary and educational purposes, performed in the public's interest and for public benefit, the general nature of the business to be transacted by the corporation is more specifically as follows:

- 1. Terrain Publishing publishes digital and print media such as websites and books, including Terrain.org—an established venue for scientific, literary and educational artistic endeavors—thereby providing information and instruction for the public on subjects useful to the individual and beneficial to the community.
- 2. Terrain Publishing hosts and sponsors educational workshops and literary events, in order to further its discourse, outreach, and promotion of science and the arts to the general public.

### **Article 7: Duration of Corporation**

This corporation will exist in perpetuity.

#### **Article 8: Additional Provisions**

- 1) Upon dissolution of this corporation: The property of this corporation is irrevocably dedicated to scientific, literary and educational purposes. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for scientific, literary and educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
- 2) Limitation on political activities: No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
- 3) Limitation on private inurement: No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.
- 4) General limitations on nonprofit activities: Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
- 5) Assurance against discrimination: This corporation will not practice or permit discrimination on the basis of sex, age, race, national origin, religion, or physical handicap or disability.
