The Limited Liability Company shall have perpetual existence.

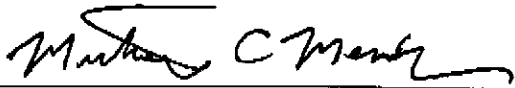
ARTICLE IV.
