ARTICLES OF INCORPORATION

SOCIATION OF ANTI-WATCHTOWER ACTIVISTS (AAWA)

In compliance with the requirements of A.R.S. Section 10-3202 et seq., as amended, the undersigned, being of eighteen years of age or more, has on this day voluntarily decided to form a not for profit corporation and does hereby certify:

ARTICLE I NAME

The name of the corporation is The Association of Anti-Watchtower Activists (AAWA), hereinafter referred to as the "Corporation".

ARTICLE II KNOWN PLACE OF BUSINESS

The initial known place of business of the Corporation is 5966 N. Moon Crest, Tucson, Arizona 85718.

ARTICLE III STATUTORY AGENT

ARTICLE IV GENERAL NATURE OF BUSINESS

This Corporation does not contemplate pecuniary gain or profit. The purposes for which it is formed are:

- (1) To work together as a group in a positive and beneficial way to help people extricate themselves from a damaging belief system, namely Jehovah's Witnesses, to assist those who are struggling with the consequences of leaving, and to inform non-Witnesses so that these are fully aware of the religion's damaging elements before joining in the first place. In order to do this effectively, our efforts will be "religiously neutral," meaning that no religious or atheistic outlook will be promoted through AAWA's activities or resources. The undersigned agree that AAWA's purpose in **not** to redirect people to any kind of alternative religious or philosophical belief system, which could potentially be just as harmful; and
- (2) To have and exercise any and all powers, rights and privileges that a corporation organized under the nonprofit corporation law of the State of Arizona may legally exercise, both now and hereafter.

ARTICLE V NO MEMBERS

The Corporation shall have no members.

ARTICLE VI BOARD OF DIRECTORS

IDENTIFICATION OF DIRECTORS: The Corporation shall be managed by a Board of Directors who shall have the exclusive right of determining and transacting the affairs of the Corporation. Unless otherwise provided in the Bylaws, directors shall hold office until their successors are elected and appointed by the directors. INDEMNIFICATION OF DIRECTORS: Any person who serves as a director shall be immune from civil liability and shall not be subject to suit directly or by way of contribution for any act or omission resulting in damage or injury if such person was acting in good faith and within the scope of his/her official capacity, unless such damage or injury was caused by the willful and/or grossly negligent conduct of said person. Official capacity is considered as any decision, act or event undertaken by the corporation in furtherance of the purpose or purposes for which such organization was organized.

The liability of a director shall not in any way be eliminated for any of the following:

- (1) Any breach of the director's loyalty to the Corporation.
- (2) Acts or omissions which are not in good faith or which involved intentional misconduct or a willful violation of law.
 - (3) Any transaction from which the director derived an improper personal benefit.

ARTICLE VII

OFFICERS

The affairs of the Corporation are to be conducted by such officers as are specified in the Bylaws and shall be elected by the Board of Directors as provided in the bylaws. The initial officers shall be as set forth in Article XII below.

ARTICLE VIII BYLAWS

The Board of Directors shall have the power and authority to enact Bylaws and amendments hereto that are not inconsistent with the provisions hereof.

ARTICLE IX DURATION

The Corporation shall commence on the date that the Arizona Corporation Commission files these Articles of Incorporation, and its duration shall be perpetual.

ARTICLE X AMENDMENTS

Any amendment to these Articles shall require the affirmative vote of a majority of the directors.

ARTICLE XI DISSOLUTION

The Corporation may be dissolved by the affirmative vote of a majority of the directors. Upon dissolution of the Corporation, other than as the result of a merger or consolidation, the assets of the Corporation shall be dedicated to an appropriate public agency or any nonprofit corporation, association, trust or other organization to be used for purposes similar to those for which this Corporation was created or for any other nonprofit purposes as may be permitted by applicable law.
