ARTICLES OF ORGANIZATION KITCHENS+LLC

The undersigned individuals acting as organizer and member of a limited liability Company under the Arizona Liability Company Act adopts the following Articles of Organization.

- 1. The name of the limited liability company is KITCHENS+LLC
- 2. The address of the registered office in Arizona is:

- 4. There is one member at the time the limited liability company is formed.

proposing to dispose of his interest, do not approve of the proposed transfer or assignment by unanimous written consent, the transferee of the member's interest shall have no right to Participate in the management of the business and affairs of the limited liability company or to become a member. The transferee shall only be entitled to receive the share of profits or other compensations by way of income and the return of contributions to which that member would otherwise be entitled.

- 8. None of the members of this limited liability company shall be personally liable for the debts or obligations of this limited liability company unless otherwise provided for under the Arizona Limited Liability Company Act or by law.
- 9. Management of the limited liability company is reserved to and is in all of the members of the limited liability company. The name and address of each member at the time of formation of the limited liability company is:
