Amendment to Articles of Incorporation of Lump Busters
A Tax-Exempt Pursuant to A.R.S. 10-2004

Registered Non-Profit Organization Lump Busters Articles of Association

Article 1 – Name of Organization Lump Busters

Article 2 - Physical Location

Lump Busters has no physical office. However, It is based out of Phoenix, Arizona

Article 3 - Purpose

Lump Busters, is a non profit organization set out to raise funds for research, diagnosis and treatment of brain tumor and cancer related illnesses.

### Article 4 – Character of Affairs

To achieve the objective stated in preceding article, Lump Busters conducts the kind of registered non-activity described below.

- (1) Activities to help promote
- (2) Activities to support individuals raising funds for cancer research

# Article 5 – Board of Directors/Incorporators

The Board of Directors and Incorporators shall be as stated in the Articles of Incorporation.

## Article 6 - Public Notices

Public Notices of Lump Busters shall be given on the organizations newsletters sent to donors, volunteers and members of the organizations.

#### Article 7 - Members

Lump Busters consists of its regular members, who shall be deemed as its volunteer member/staff under the Law for the Promotion of Registered Non-profit Organization.

(1) Regular members are individuals and groups willing to join Lump Busters as its objective meets with their approval. Article 8 - Admission

Admission is based on voluntary participation.

Article 9 – Membership Fee Membership fee not applicable

Article 10 - Succession

There will be no requirement for members to inform or submit their notice for withdrawal from the organization.

Article 11 – Officers President/Treasurer, Terri Gall Vice President, Gary Gall Secretary, Karen Rush

Article 12 - Duties of Officers

Duties of these officers and the board of Lump Busters are:

Choosing fundraising events to participate

Organizing and facilitating fundraising events

Collaborating on distributing monetary donations related to brain tumor or cancer related research, diagnosis, or treatment

Article 13 – Functions

Functions held:

Potato Bar

Concession Stand

Lump Busters product sales (insulated cups)

Fundraising activities which are approved for Non-Profit Corporations

Article 14 - Organization of meetings

Meetings held at private venues. Attending members includes all Lump Busters officials.

Article 15 - Management of properties

Donations determined by the Officers

Article 16 – Fiscal Year

The Fiscal year of the corporation shall be July 1st – June 30th

Article 17 - Project and Budget Planning

Determined by the Officers as needed

Article 18 - Project and Financial Statement Shall be included with 1023 application filing

Article 19 – Dissolution In case of dissolution of the Lump Busters organization all remaining assets will be donated to National Brain Tumor Society.
