ARTICLES OF INCORPORATION

PRESENTS:

THAT WE, the undersigned, have this date associated ourselves together for the purpose of forming a non-profit corporation pursuant to the laws of the

State of Arizona and for that purpose, do hereby adopt these Articles of Incorporation.

ARTICLE I

The name of the corporation shall be Dugans' St. Patrick's Foundation,

ARTICLE II

The time of commencement of this corporation shall be the date that the Articles of Incorporation are delivered Arizona Corporation Commission. The corporation shall have perpetual existence.

ARTICLE III

The known place of business of the corporation shall initially be 2035 N. Overfield Road, Casa Grande, AZ 85194. The corporation shall also initially maintain a mailing address of 2035 N. Overfield Road, Casa Grande, AZ 85194, but the corporation may establish other principal places of business, mailing addresses and other offices at such other places, either within or without the State of Arizona, as the Board of Directors may from time to time determine.

ARTICLE IV

This organization is organized for and shall be operated as a non-profit corporation solely and exclusively for charitable, educational and recreational purposes within the meaning of Sections 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The initial purpose of the corporation is to aid and assist young people in need in Pinal County, a non-exclusive but specifi

organization shall inure to the ben of, or be distributed to its member trustees, officers, or other private p sons, except that the organization sl be authorized and empowered to ; reasonable compensation for service rendered and to make payments a distributions in furtherance of the p poses set forth in the purpose clair hereof. No substantial part of the ac ities of the organization shall be carrying on of propaganda, or oth wise attempting to influence legislati and the organization shall not part pate in, or intervene in (including publishing or distribution of sta ments) any political campaign behalf of any candidate for pul office. Notwithstanding any other pre sion of this document, the organizat shall not carry on any other activit not permitted to be carried on (a) by organization exempt from income tax under Section 501(c)(3) the Internal Revenue Code, or coi sponding section of any future code, or (b) by an organization, cor butions to which are deductible un Section 170(c)(2) of the Inter Revenue Code, or corresponding s tion of any future federal tax code. ARTICLE VII

Upon the dissolution of the orga zation, assets shall be distributed one or more exempt purposes wit the meaning of Section 501(c)(3) of Internal Revenue Code, or correspo ing section of any future federal code, or shall be distributed to the f eral government, or to a state or lo government, for a public purpose. / such assets not disposed of shall disposed of the Court of Committee Pleas of the county in which the pris pal office of the organization is th located, exclusively for such purpor or to such organization or organi tions, as said Court shall determi which are organized and opera exclusively for such purposes.

ARTICLE VIII

The Bylaws of the corporation sl govern the conduct of the affairs of corporation. The corporation shall have members, but instead shall appeared by a self-percetuating Bo
