Crown Foundation - Response to Question 10B

Armorworks Enterprises, LLC

Timothy Crown ("Tim Crown") and Eric Crown ("Eric Crown"), both Arizona residents, each had a 50% membership interest in C Squared Capital Partners, LLC, an Arizona limited liability company ("C2"). C2 has a 40% membership interest in Armorworks Enterprises, LLC, an Arizona limited liability company ("AWE"). Anchor Management, LLC ("Anchor"), an Arizona limited liability company owned 50% by Tim Crown and Eric Crown, served as a co-manager of AWE until July 13, 2009, at which time Anchor was unilaterally removed from being co-manager. On February 14, 2013, the Arizona superior court ruled that Anchor was improperly removed from being co-manager. Subsequent to the Arizona superior court's ruling, AWE amended its filings with the Arizona Corporation Commission to reflect that Anchor remains as co-manager. On June 17, 2013, the other co-manager, William Perciballi without Anchor Management's or C2's consent filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code for AWE. C2 and Anchor Management have objected to the unauthorized bankruptcy and the matter is still pending before the Bankruptcy Court. AWE primarily transacts business in Arizona, and its address was 305 N 54th Street, Chandler, Arizona 85226.

HotStix Golf, LLC

Timothy Crown ("Tim Crown") and Eric Crown ("Eric Crown"), both Arizona residents, each had a 33.33% membership interest in StormWind 1, LLC, an Arizona limited liability company ("SW 1"), and also each had a 33.33% membership interest in StormWind 2, LLC, an Arizona limited liability company ("SW 2"). SW 1 had a 0.75% membership interest in Hotstix Golf, LLC, a Delaware limited liability company ("HotStix"). SW 2 had a 74.29% membership interest in HotStix. Thus, SW 1 and SW2 had a combined 75.04% membership interest in HotStix. Tim Crown served in a personal capacity as a manager on the Board of Managers of HotStix until July 23, 2009, at which time he resigned from that position effective immediately. Tim Crown was not, at the time of his resignation, or at any time prior to his resignation, involved in the day-to-day operations of the business of HotStix. HotStix primarily transacted business in Arizona, and its address was 14825 N. 82nd Street, Scottsdale, Arizona 85260.

On October 26, 2009, a group of HotStix creditors filed an involuntary bankruptcy petition against HotStix requesting an order for relief under Chapter 7 of the Bankruptcy Code (Title 11 of the United States Code). The dates of corporate operation of HotStix were approximately from 2006 through the date of the bankruptcy.

Crown Foundation - Response to Question 10B (continued)

944 Media, LLC

Tim Crown and Eric Crown are each 50% members of Orbitron Holdings, LLC, an Arizona limited liability company ("Orbitron"). Orbitron has a 51.02% membership interest in 944 Media, LLC, a Delaware limited liability company ("944"). Tim Crown and Eric Crown served in their personal capacities as managers on the Management Committee of 944 until March 25, 2010, at which time they both resigned from those positions effective immediately. Neither Tim Crown nor Eric Crown were, at the time of their resignations, or at any time prior to their resignation, involved in the day-to-day operations of the business of 944. 944 published a national magazine in approximately 11 cities across the United States, and had its headquarters in California at 9100 Wilshire Blvd, Suite 700W, Beverly Hills, CA 90212.

On April 6, 2010, 944 filed a voluntary bankruptcy petition requesting relief under Chapter 11 of the Bankruptcy Code (Title 11 of the United States Code). The dates of corporate operation for 944 were approximately from 2004 through December 17, 2010, when 944 sold all of its assets in a bankruptcy-court approved sale to a third-party purchaser. 944 continues to operate in a minimal capacity as it winds up its affairs.
