7. Whether the Judgment Debtor(s) is subject to an existing wage assignment, garnishment or levy, and if so, the name, address and telephone number of that Judgment Creditor.

8. The name, address and telephone number of the Garnishee.

9. The date and manner of delivery of a copy of the Answer to the Judgment Debtor(s) and Judgment Creditor.

FROM AND AFTER SERVICE of the Writ of Garnishment, the Garnishee shall not pay to the Judgment Debtor(s) any earnings which are not exempt.

IF IT APPEARS FROM THE ANSWER OF THE GARNISHEE that the Garnishee was indebted to the Judgment Debtor(s) any earnings which are not exempt.

IF IT APPEARS FROM THE ANSWER OF THE GARNISHEE that the Garnishee was indebted to the Judgment Debtor(s) for disposable earnings when the writ was served, the garnishment shall be continuing in nature as a lien against nonexempt earnings, A.R.S. \$12-1598.05.

AS TO DISPOSABLE EARNINGS, as defined in A.R.S. \$33-1131, a garnishment is continuing in nature, subject to the following conditions:

1. The garnishment constitutes a lien against non-exempt earnings.

2. The garnishment is the equivalent of a court ordered assignment, compelling the garnishee to remit the non-exempt earnings to the Plaintiff, as they are earned, A.R.S. \$12-1598.10.

3. The garnishment shall survive until any of the following occurs:

a. The underlying judgment is satisfied in full, is vacated, or expires.

b. The Judgment Debtor(s) leaves the Garnishee's employ for more than sixty (60) days.

c. The Judgment Creditor releases the garnishment.

d. The proceedings are stayed by a court of competent jurisdiction, including the United States Bankruptcy Court.

e. The Judgment Debtor(s) has not earned any non-exempt earnings for at least sixty (60) days.

4. Garnishments, levies and wage assignments which are not for the support of a person are inferior to wage assignments for the support of a person. Garnishments which are not for the support of a person and levies are inferior to garnishments for the support of a person.

5. If a Judgment Debtor(s)' earnings become subject to more than one Writ of Garnishment, and because of the application of the priorities, a Judgment Creditor recovers no non-exempt earnings for two (2) consecutive paydays, the lien on earnings of such Judgment Creditor is invalid and of no force and effect, and the Garnishee shall notify the Judgment Creditor accordingly.

8. Defendant Messinger Mortuary Family, L.L.C., upon information and belief, is an Arizona limited liability company doing business throughout Arizona and with a domestic address is located in Scottsdale, Maricopa County, Arizona

9. Defendant Messinger Family Limited Partnership, upon information and belief, is an Arizona limited partnership doing business throughout Arizona and with a domestic address located in Scottsdale, Maricopa County, Arizona.

7 The true names, capacities, and/or relationships, whether individual, corporate, 10. 8 partnership, or otherwise of Black Corporations, I-X; White Partnerships, I-X, John and Jane 9 Does, I-X, inclusive and each of them, are and were unknown to Plaintiffs at the time of filing this Complaint. 12. Plaintiffs are five brothers who are the adult children of Hilda Kjell (deceased).

13. Hilda Kjell ("Hilda") died on or about January 26, 2013. She died after a long
battle with Alzheimer's disease and other long-term, terminal health conditions.

14. Following Hilda's death, the Plaintiffs searched for a reputable funeral home that
would properly cremate their mother's body and return her ashes to Plaintiffs.

24 15. Defendants have marketed themselves as a well trusted network of funeral homes
25 that handle human remains with dignity and respect.

1 16. Messinger boasts on its website that it prides itself on "providing extra services
 2 and support, and doing whatever we can to make a painful time more bearable."

3 17. Messinger also claims that it is "one of the most respected funeral homes in
4 Arizona."

5 18. Based on Defendants' own representations relating to their reputation and
6 expertise in handling a family's grieving after a death, Plaintiffs agreed to use Defendants'
7 services for cremation of Hilda.

8 19. After Hilda's death, Plaintiffs had her body delivered to Defendant's facility
9 located in Payson, Arizona. Plaintiffs instructed Defendants to cremate Hilda's remains and to
10 return Hilda's ashes to Plaintiffs. On or about January 30, 2013, Plaintiffs' mother, Hilda Kjell,
11 was cremated by Mountain Meadows Crematory.

12

20. Defendants pre-arranged to pick up Hilda's remains on or about February 2, 2013.

13 21. Plaintiffs planned to pay their final respects to their mother by spreading her ashes
14 in multiple locations across the United States. All of the locations that Plaintiffs were to visit
15 with Hilda's ashes were of special emotional significance to Hilda and her sons during Hilda's
16 life.

Accordingly, several months after Hilda's death, all five Plaintiffs departed for a
 multi-city trip to spread Hilda's ashes in emotionally significant places. Plaintiffs believed that
 this trip would act as a final act of respect for their mother and closure for their family.

20 23. Plaintiffs spent considerable time and expenses organizing their trip which lasted
 21 approximately ten (10) days.

22 24. During their cross-country journey, Plaintiffs used the opportunity to reminisce
23 about their mother, shared stories from their childhood, and even addressed their mother by
24 name while talking with what they believed were her ashes.

25 25. Plaintiffs later discovered that the ashes delivered to them by Defendants were not
26 actually those of their mother.

1	26. When reviewing various documents related to their mother's death and cremation,
2	Plaintiffs discovered that they had been delivered the remains of another woman named Helen
3	Liddell, not Hilda Kjell.
4	<u>COUNT I</u>
5	(Negligence)
6	27. Plaintiffs hereby incorporate by reference all allegations included in paragraphs 1
7	through 26 above.
8	28. Defendants owed a duty of care to Plaintiffs to properly handle the remains and
9	body of Hilda Kjell after her death and deliver her ashes to Plaintiffs after Hilda's cremation.
10	29. Defendants breached their duty of care owed to Plaintiffs by mishandling the
11	remains of Hilda Kjell and by delivering the ashes of Helen Liddell to Plaintiffs rather than the
12	ashes of Hilda Kjell.
13	30. As a result of Defendants' breach, Plaintiffs have damages, including but not
14	limited to emotional distress, and other damages in an amount to be proven at trial.
15	WHEREFORE, Plaintiffs pray for judgment against Defendants as follows:
16	A. A judgment be entered in their favor and against Defendants in an amount
17	to be determined at trial;
18	B. That they be awarded their costs incurred in filing this matter;
19	C. For such other and further relief as the Court deems just and appropriate.
