The undersigned incorporators, to form a nonprofit corporation under and pursuant to the laws of the State of Arizona, do hereby adopt these Articles of Incorporation:

ARTICLE I

Name. The name of the Corporation shall be FOR FUN AND FOR FREE.

ARTICLE II

Incorporators. The names and addresses of the Incorporators are:

Russ Muellenberg, 2539 S Cliffview, Flagstaff, AZ 86001

ARTICLE III

Purpose. The Corporation is organized exclusively for one or more of the purposes specified in Section 501(c)(3) of the Internal Revenue Code, including the making of distributions to organizations that qualify as exempt under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV

Specific Purpose. The Corporation is organized to provide residential housing with an alcohol free environment for recovering alcoholics.

ARTICLE V

Capital Stock and Director Liability. The Corporation shall have no capital stock and the private property of Incorporators, Members, Directors and Officers of the Corporation shall at all times be exempt from all corporate debts and liabilities whatsoever.

ARTICLE VI

Statutory Agent. The name and address of the initial statutory agent of the Corporation is:

ARTICLE VII

Board of Directors. The initial Board shall consist of two Directors who shall serve until the first Annual Meeting or until their successors are duly elected. The initial Directors and their addresses are:

Thereafter, the number of Directors and the time and manner of their election shall be fixed by the Bylaws.

ARTICLE VIII

Duration. The duration of the Corporation shall be perpetual.

ARTICLE IX


Additional Provisions. Upon dissolution of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable and/or educational purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Tax Code.

No substantial part of the activities of the Corporation shall consist of carrying on Propaganda, or otherwise attempting to influence legislation, except as otherwise provided by Section 501(c)(3) of the Internal Revenue Code, and the Corporation shall not participate in, or intervene in (including publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments in furtherance of the purposes set forth in these Articles. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

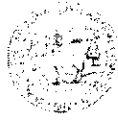




