**ARTICLE I**  
**NAME**

**Section 1.** The Limited Liability Corporation (LLC) existing under these By-Laws is to be known as Up in Smoke Firearms Training, LLC and/or USFT, LLC of Peoria, Arizona.

**Section 2.** The purposes of the LLC are set forth in Article II of the Constitution and within Article IV, section 1 of the By-Laws.

**ARTICLE II**  
**MANAGEMENT**

**Section 1.** Management of the LLC's real property, management of lease or rental agreements will be maintained by the Member-Manager and shall have entire charge of any and all real property belonging to or in the custody of the LLC (i.e. Buildings, Land, Lots, etc.) and shall approve leases, sub-leases and shall handle any transactions pertaining to the real property owned or being controlled by the LLC.

**Section 2.** The government and management of the LLC activities and day to day business of the LLC shall be entrusted to the managing-member and/or statutory agent.

**Section 3.** Additional members may be added to the LLC acting as sub-contractors, but the LLC and its Managing-Member will not be held liable for the actions for the additional members, whom would be required to provide to the LLC their own personal liability & property insurance that would hold them liable while acting in the performances and actions as a sub-contractor under the LLC.

**Section 4.** Each sub-contracted member of the LLC would be required to include the LLC to their own personal liability & property insurance upon assuming a position as a member of the LLC in order to protect the LLC from any civil or criminal liabilities while in the performance of representing the LLC during the course of hire as a sub-contractor.

**Section 5.** Each sub-contracted member of the LLC will be responsible for his/her own medical insurance coverage plan and no such plan would be afforded by the LLC. Any personal injuries or property damage caused during or because of the sub-contracted member(s) will be assumed and responsible by the sub-contracted member(s) of the LLC and the LLC itself will not be held responsible or assume or be held liable during any civil or criminal actions in the court of law.

**Section 6.** Each sub-contracted member(s) of the LLC will be responsible for his/own State and Federal taxes, as well as filing for Social Security allotments/deductions.

**ARTICLE III.**  
**LIMITATIONS OF LIABILITIES**

**Section 1.** The business is a LLC and no individual will be held responsible for liabilities or obligations incurred.

**ARTICLE IV.**  
**PURPOSE OF THE LLC**

**ARTICLE I**  
**NAME**

**Section 1.** The Limited Liability Corporation (LLC) existing under these By-Laws is to be known as Up in Smoke Firearms Training, LLC and/or USFT, LLC of Peoria, Arizona.

**ARTICLE II**  
**NATURE**

**Section 1.** The nature of the LLC is the instruction, coaching, and mentorship of firearms training programs offered through the National Rifle Association (NRA), Civilian Marksmanship Program (CMP), Arizona Peace Officer and Standards in Training (AZ POST), Arizona Department of Public Safety (AZ DPS), USA Shooting Sports, The American Legion, Boys Scouts of America (BSA), and any other formal certification training that public citizens or retired public safety persons seek in shooting sports program and/or recreation. The LLC would be acting as a private and sole agent teaching courses offering certifications given by the organizations previously mentioned.

**Section 2.** Classes offered by the LLC will be accomplished by certified instructors and coaches that have received credentialing by and not limited to the organizations mentioned in Section 1 of Article II, and/or any other organizations offering certifications for firearms training or recreational use. Additional instruction and certifications will and can be offered to public citizens or retired police officers, such as, but not limited to; the Law Enforcement Officer Safety Act (LEOSA), Concealed Carry of Weapons (CCW), and etc.

**Section 3.** Each Instructor/Coach/Mentor (Manager-Member and Sub-Contractors) within the LLC will also be a certified NRA Range Safety Officer (RSO) prior to teaching/instructing any courses by the organizations listed in Section 1 of Article II.

**Section 4.** Each Instructor/Coach/Mentor (Manager-Member or Sub-Contractors) within the LLC wishing to teach/instruct a NRA Range Safety Officer (RSO) course must first have been certified as a NRA Chief Range Safety Officer (CRSO).

**Section 5.** The LLC also provides the services of maintenance and gunsmith activities of firearm platforms that needs repairs and maintenance as requested by customers. Each person of the LLC should be certified prior to accomplishing any such actions of firearms as to reduce any possibilities of damages sustained during repairs/maintenance.

**ARTICLE III**  
**FINANCES**

**Section 1.** All finances and payments of services will be reflected with the name of the LLC, such as; Up in Smoke Firearms Training, LLC and/or Dan P. Palmer.

**Section 2.** The LLC will file all state, local and federal income taxes as regulated by the state and federal governments, as outlined in the policies/procedures and laws.

## **ARTICLE IV** **AUTHORITY**

**Section 1.** The authority and administration of the LLC will be granted to the Manger-Member and Statutory Agent(s) of the LLC, whom will be responsible for the banking institution financial responsibilities and whom may sign any authorize checks or use any credit card and/or debit card transactions as seemed necessary for the LLC.
