**ARTICLES OF AMENDMENT NO. 2 TO ARTICLES OF ORGANIZATION
OF
NORTHERN ARIZONA DERMATOLOGY CENTER MEDICAL BUILDING L.L.C.**

Pursuant to ARS § 29-633, NORTHERN ARIZONA DERMATOLOGY CENTER MEDICAL BUILDING L.L.C., an Arizona limited liability company (hereafter "**Company**"), hereby adopts the following Articles of Amendment No. 2 to its Articles of Organization:


4. Except as amended hereby, the Company's Articles of Organization shall remain in full force and effect.
