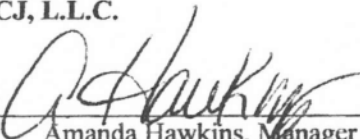
ARTICLES OF AMENDMENT**OF****2CCJ, L.L.C.**
