EXHIBIT A

ARTICLE I

NAME AND PERPETUAL DURATION

The name of the corporation shall be **Military Support Foundation**, hereinafter referred to as the "Corporation," and the Corporation shall remain in effect in perpetuity, unless earlier terminated by the Board of Directors upon the same vote as is required to amend these Articles.

ARTICLE II

PURPOSE AND CHARACTER OF AFFAIRS

1. The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the general corporation law of Arizona but limited to those activities consistent with activities permitted for organizations described in Section 501 © (3) of the Internal Revenue Code of 1986 as amended. The Purpose of the corporation shall specifically include (but shall not be limited to) providing worldwide relief and aid to reduce human animal suffering as a result of hunger, poverty, disease, war, natural disasters and other circumstances creating widespread human need and engage in feeding, food, education and Medical Aid distribution activities for charitable classes of persons throughout the state of Arizona, the United States and appropriate foreign countries.

ARTICLE III

POLICY

It shall be the policy of the Corporation:

SECTION 4: To promote and encourage distribution food and material aid to needy military personal and families in southern Arizona, throughout the state of Arizona, the United State of America and in foreign locations.

ARTICLE IV

STATUTORY AGENT
