If in fact an Arizona Revised Statute has changed regarding the formation of a Limited Liability Company as the rejection letter has indicated but does not identify, it would still be covered and included in the Phrase ARS§ 29-601, et seq., as ARS 29-601 is the first Statute pertaining to LLCs. For your convenience, I have provided two definitions from a couple of dictionaries.
