Articles of Organization of Tungate Chiropractic PLLC Single Member Limited Liability Company

The undersigned, desiring to organize and establish a single member limited liability company pursuant to the laws of the State of AZ, executes these Articles of Organization this 25 day of May, 2021.

Article I Name

The name of the single member limited liability company is Tungate Chiropractic PLLC, Single Member Limited Liability Company.

Article II Duration

The period of duration for this single member limited liability company is fifty (50) years from the date of filing the Articles of Organization with the appropriate state filing office, unless extended and/or sooner dissolved by the members or as provided by state law.

Article III Purpose

The purpose for which this single member limited liability company is organized is to Chiropractic and to otherwise perform any lawful purpose.

Article IV Principal Place of Business
