The articles of incorporation for this corporation were filed with the Office of the Corporation Commissioner of the State of Oregon on August 29, 1988, under the corporate name Madden Industrial Craftsmen, Inc. This present instrument is the first amendment and restatement amendment of the articles of incorporation.

These articles of restatement are filed pursuant to ORS 60.451 (restatement of articles of incorporation), ORS 60.431 (authority to amend articles of incorporation), 60.241(4) and 60.247(2) (change of voting rights), 60.437 and 60.447 (procedure for amendment), 60.441 (class voting), 60.211 and 60.341 (vote of shareholders and directors without a meeting), and 60.437(4), 60.451(3), and 60.217(1) (waiver of notice of meeting), and pursuant to 26 USC 354 and 368(a)(1)(E) (tax-free exchange of stock in recapitalization).

The following information is provided.

### Article III Duration

The duration of this corporation shall be perpetual. If the corporation is liquidated according to law, its assets shall be distributed to creditors, shareholders, and other persons, as required or permitted by law.

### Article IV Shares of Capital Stock

- (1) Under the original articles of incorporation (filed August 29, 1988), the corporation was authorized to issue 700 shares of voting, no-par-value, common stock.
- (2) (a) From and after the date of the filing of the corporation's first restatement of its articles of incorporation, the corporation shall have authority to issue zero shares of preferred stock, 400 shares of class A voting common stock, and 900 shares of non-voting common stock.
  - (b) Each share of class A common stock shall entitle the holder to one vote with respect to matters on which shareholders have the right to vote. Whether or not the holders of other classes of capital stock have the right to vote on a particular matter by favor of statute, article of incorporation, by-law, or otherwise, no matter requiring the vote of shareholders shall be passed or allowed unless that matter has been submitted to the shareholders and has received the affirmative vote of at least a majority of the total number of class A common shares then outstanding or eligible to be voted.
  - (c) Except as otherwise provided by statute, the holders of class B common stock shall have no right to vote on any matter.
  - (d) Cumulative voting for directors shall not be allowed.
  - (e) Except as provided in subsection (b) and (c) of this section (2) (differences in right to vote), all shares of class A and class B common stock shall have equal rights and

preferences as capital stock in the corporation and each such share shall carry equal rights as to distributions of earnings and distributions in liquidation. Class A common shares and class B common shares both shall be deemed to be shares of the same class of stock for purposes of 26 USC 1361(b)(1)(D) and 2701(a)(2)(B), or their respective later enacted analogues.

(3) From and after the date of the filing of the corporation's first restatement of its articles of incorporation, each share of old common stock then outstanding shall become (i) one share of class A common stock plus (ii) one and one-half shares of class B common stock. In the case of iractional shares issued to a shareholder as a result of foregoing conversion and recapitalization, those fractional shares may, at the corporation's election, be redcemed for cash equal to the fractional part of \$350.00 per new common share.

### Article V Board of Directors

The corporation shall be governed by a board of not less than three nor more than nine directors, as may be elected from time to time by the voting share-holders.

- 3. This restatement provides for the reclassification and exchange of issued shares. The provisions for implementing the restatement are contained in the restatement itself, set out above.
- 4. This restatement was adopted by the corporation's board of directors on Appendix 12 1954.
- 5. This restatement required approval of the shareholders and was approved by a vote of the corporation's share-nolders on Note that 22, 155 , as follows:
