Articles of Association Amendment - Erroneous Facts Requiring Amendment

My name is Jacqueline Nguyen (aka. Thao Nguyen) and I am the Owner of Dessert Queen LLC ('DQ'). As required by the Arizona Corporation Commission's ('ACC') Articles of Amendment Instructions L015i. I am advising of an amendment to DQ's Articles of Organization ('AoO'), due to an erroneous statement included in the same.

In late 2018, an acquaintance and I had been discussing various aspects of DQ, one of which was the possibility of dividing strategy and management tasks between us. I prepared documentation setting out how such an arrangement might work and provided it to the acquaintance for comment. The acquaintance had a different view of how such an arrangement might work and did not return the documentation or provide comments. We had several further discussions on this subject; however, we were unable to agree on a definitive way forward.

I recently engaged the services of a business consultant to provide advice on a range of matters relating to DQ. In the course of providing advice, the consultant identified that DQ had erroneously stated that it had two members, when in fact, it had only ever had one. The consultant advised that the acquaintance should not have been included as a member of DQ, given that her and I were not carrying on a trade, business, financial operation, or venture together. We were also not dividing the profits arising from the same.

Upon receiving this advice, I contacted ACC (as required) to advise of the error and to advise of an amendment DQ's AoO effective January 1, 2022. ACC has actioned this request and provided confirmation of the same on January 22, 2022. However, after speaking with the consultant again, he advised that DQ's AoO were still erroneous in relation to the period up to and including December 31, 2021, as I was DQ's sole member from the very start. As such, I am advising ACC (as required) that DQ's AoO have been amended to correctly state that DQ has always been a single- member LLC since 07/01/2019.
