10. Capital Stock 11. Indemnification	The amount of total authorized capital stock, which the Corporation shall have authority to issue, is 70,000,000 shares of common stock, each with \$0.001 par value. The shares of common stock shall (a) have unlimited voting rights and (b) be entitled to receive the net assets of the Corporation upon dissolution. No cumulative voting, on any matter to which stockholders shall be entitled to vote, shall be allowed for any purpose. Stockholders shall not have preemptive rights to acquire unissued shares of the stock of this Corporation.
