FIRST: The name of the Corporation is:

FORACTION TECH INC.

SECOND: The address of the Corporation's registered office in the State of Delaware is 2915 Ogletown Road, in the City of Newark, County of New Castle, 19713. The name of its registered agent at such address is CorpoMax Inc.

THIRD: The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Delaware.

FOURTH: The total number of shares of stock which the Corporation shall have authority to issue is One Thousand Five Hundred (1,500). All such shares are to be Common Stock, with no par value, and are to be of one class.

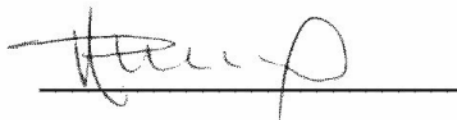

SEVENTH: In furtherance and not in limitation of the powers conferred by the laws of the State of Delaware, the Board of Directors of the Corporation is expressly authorized to make, alter and repeal the bylaws of the Corporation, subject to the power of the stockholders of the Corporation to alter or repeal any bylaw whether adopted by them or otherwise.

Any amendment, modification or repeal of the foregoing sentence shall not adversely affect any right or protection of a director of the Corporation hereunder in respect of any act or omission occurring prior to the time of such amendment, modification, or repeal.
