**ARTICLE I**

**Name**

**Capital**

The authorized capital of the Company shall consist of percentage interests or units of interest in the Company, which may be issued in separate classes and series of units, as provided in the Company's Operating Agreement, and which shall have the designations, rights, preferences, privileges and voting rights as set forth in the Company's Operating Agreement from time to time.

**ARTICLE IX**

**Liability and Indemnification**

Except as provided under Chapter 7 of Title 29 of the Arizona Revised Statutes, as amended from time to time, a member, manager, employee, officer or agent of the Company is not liable, solely by reason of being a member, manager, employee, officer or agent, for the debts, obligations and liabilities of the Company, whether arising in contract or tort, under a judgment, decree or order of a court, or otherwise. The Company shall indemnify, to the maximum extent from time to time permitted by applicable law, any person who incurs liability or expense by reason of such person being a member, manager, employee, officer, or agent of the Company. This indemnification shall be mandatory in all circumstances in which indemnification is permitted by law. In addition, the Company shall advance the costs of defense (including costs of investigation) if claim or suit is asserted against any member, manager, employee, officer or agent in connection with such person acting on behalf of the Company, upon the execution of a written undertaking to the Company that such person will repay to the Company the full amount of such advances, plus interest at the short term federal rate, if it is determined by a court of competent jurisdiction or an arbitrator that such person is not entitled to indemnity.
